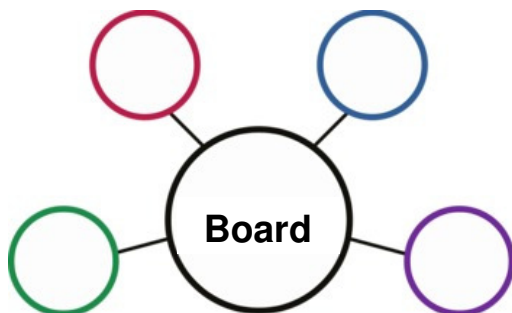

Subgroups to the Partnership Board



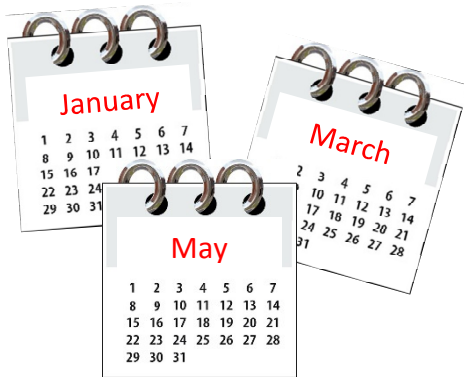
Subgroups will be set up when needed to complete a project

Representatives from other services (e.g. housing, transport, employment, education, leisure) should be drawn on when necessary and included in the subgroups and work streams of the Board

Warrington Joint Autism and Learning Disability Partnership Board

The chairs of each subgroup should take responsibility for inviting the relevant people to attend the Partnership Board when discussions are taking place around their areas of responsibility

How often do we come to meetings?



The Partnership Board will meet every other month

All members of the Partnership Board are expected to attend each meeting

If any members cannot attend they should send apologies before the meeting

If representatives cannot attend the Partnership Board they may send a deputy

Agendas and minutes



All papers will be sent out before the meeting

Two sets of minutes will be done. One will be an account of the meeting in pictures (easy read). The other will be a written account.

Minutes will be sent out quickly so that people can give feedback
