**ROAD TRAFFIC REGULATION ACT 1984**

**THE BOROUGH OF WARRINGTON (COVID-19 RESPONSE) (WINWICK STREET) (BUS STAND, VARIOUS PROHIBITIONS/RESTRICTIONS & SUSPENSIONS) TEMPORARY ORDER 2020**

**NOTICE IS HEREBY GIVEN** that, in not less than 7 days from the date of this Notice, the Council intends to make an Order under Section 14 of the Road Traffic Regulation Act 1984. The effect of which will be to introduce the following restrictions: -

1. Temporarily suspend the Order specified in Column 1 of the Schedule to this Notice to the extent as detailed in Column 2 of the said Schedule.
2. To prohibit any Motor Vehicle from waiting at any time on the east side of Winwick Street from its junction with John Street for a distance of 5 metres in a southerly direction.
3. To introduce a Bus Stand on the east side of Winwick Street from a point 5 metres south of its junction with John Street for a distance of 32 metres in a southerly direction, operational Monday to Saturday between the hours of 7am and 7pm and a Sunday between the hours of 9am and 5pm.
4. To introduce limited waiting prohibiting any Motor Vehicle from waiting for a period of more than 30 minutes with no return within 1 hour, every day, between the hours of 8am and 6:30pm on the east side of Winwick Street from a point 37 metres south of its junction with John Street for a distance of 18 metres in a southerly direction.
5. To introduce a one way restriction prohibiting any Motor Vehicle from proceeding in a westbound direction on John Street between its junction with Winwick Street and its junction with Ashton Street, except for Pedal Cycles.

The order will be effective from 7<sup>th</sup> July 2020 for a maximum period of 18 months and will be effective as and when indicated by traffic signs on site. This Order supersedes any contravening orders. The restrictions are required to facilitate COVID-19 response and recovery measures.

The Borough of Warrington (Traffic Management) (Civil Enforcement) Consolidation Order 2018	Is suspended in so far as it relates to the following: - <b><u>Schedule 3 – No Waiting at any time:</u></b> <b>Winwick Street (East Side)</b> - From its junction with John Street for a distance of 10 metres in a southerly direction. <b><u>Schedule 48 – Waiting limited to 30 minutes, every day 8:00am to 6:30pm, No return within 1 hour:</u></b> <b>Winwick Street (East Side)</b> - From a point 10 metres south of its junction with John Street for a distance of 45 metres in a southerly direction.
