**ROAD TRAFFIC REGULATION ACT 1984**

**THE BOROUGH OF WARRINGTON (COVID-19 RESPONSE) (VARIOUS PROHIBITIONS, RESTRICTIONS & SUSPENSIONS IN LYMM VILLAGE) TEMPORARY ORDER 2020**

**NOTICE IS HEREBY GIVEN** that, in not less than 7 days from the date of this Notice, the Council intends to make an Order under Section 14 of the Road Traffic Regulation Act 1984. The effect of which will be to introduce the following restrictions: -

1. Temporarily suspend the Order specified in Column 1 of Schedule 1 to this Notice to the extent as detailed in Column 2 of the said Schedule.
2. To prohibit any Motor Vehicle from waiting at any time in the roads specified in Column 1 of Schedule 2 to this Notice to the extent specified in Column 2 of the said Schedule.
3. To prohibit all vehicles including ridden pedal cycles and horse-drawn vehicles from entering the length of road specified in Column 1 of Schedule 3 to this Notice to the extent specified in Column 2 of the said Schedule.

The restrictions will be effective from 20<sup>th</sup> August 2020 for a maximum period of 18 months and will be effective as and when indicated by traffic signs on site. This Notice supersedes any contravening orders. The restrictions are required to facilitate COVID-19 response and recovery measures. Pedestrian access will not be affected.
