Definition

- Any incident or pattern of incidents of controlling, coercive, threatening behaviour, violence or abuse between those aged 16 or over who are or have been intimate partners or family members regardless of gender or sexuality.
- The abuse can encompass but is not limited to:
- psychological
- physical
- sexual
- financial
- emotional.
- Controlling behaviour is a range of acts designed to make a person subordinate and/or dependent by isolating them from sources of support, exploiting their resources and capacities for personal gain, depriving them of the means needed for independence, resistance and escape and regulating their everyday behaviour.
- Coercive behaviour is an act or a pattern of acts of assault, threats, humiliation and intimidation or other abuse that is used to harm, punish, or frighten their victim.
- This definition includes so called 'honour' based violence, female genital mutilation and forced marriage, and is clear that victims are not confined to one gender or ethnic group.



Domestic Abuse Governance Structure





DA Bill (1)

- The Bill will create, for the first time, a cross-government statutory definition of domestic abuse.
- The Bill recognises that a child who sees or hears or experiences the effects of the abuse is a victims of domestic abuse in their own right.
- Established the Domestic Abuse Commissioner role who has been appointed, Nicola Jacobs.
- Will stablish a new Domestic Abuse Protection Notice and Domestic Abuse Protection Order with positive action, giving police more powers.



(2)

- Creates a statutory presumption that victims of domestic abuse are eligible for special measures in the criminal, civil and family courts.
- Prevents perpetrators from cross-examining their victims in person in the civil and family courts in England and Wales.
- Ban on consent to 'rough sex' being used as a defence in murder cases.
- Places a duty on local authorities in England to provide support to victims of domestic abuse and their children in refuges and other safe accommodation. (A funding announcement has been made to assist LA's with this duty in October 2020)



(3)

- Extends the extraterritorial jurisdiction of the criminal courts in England and Wales, Scotland and Northern Ireland to further violent and sexual offences. (to comply with the Istanbul convention 2012). (This means British citizens/ permeant residents can be held accountable for crimes committed abroad on their return to the UK).
- Subject perpetrators to polygraph testing as a condition of their licence following their release from custody.
- Places Clare's law on a statutory footing.
- Victims of domestic abuse will be automatically awarded' priority need' for homelessness assistance.
